### PETITION FOR THE RECALL OF MAYOR ROGER PURCELL

We, the undersigned registered voters of Houston, Alaska demand the recall of Roger Purcell from the office of Mayor, and member of the city council, of the City of Houston.

Mayor Purcell did operate a fully equipped 2009 Houston Police Ford Explorer on December 3, 2009 to transport himself and his wife from Houston, Alaska to Fairbanks, Alaska for the purpose of executing a grant and was recorded with the equipped police vehicle's video recording system which is automatically activated when the vehicle's emergency lights are activated. Mayor Purcell, a known, former police officer, having received formal training on the proper activation of the vehicles emergency lights did violate 13AAC 02.517 by activating the emergency lights not in response to an emergency call or in pursuit of an actual or suspected violator of a statute, regulation or ordinance, or responding to but not returning from a fire alarm, or in the performance of his official duties as Mayor of executing a grant displays a gross misconduct in office, incompetence, and a failure to perform those duties as prescribed by willfully and knowingly operating an emergency vehicle contrary to 13 AAC 02.517 and as such should be recalled.
